- Be it enacted by the Legislature of the Virgin Islands:
- 2 **SECTION 1.** Title 3, chapter 33, section 881a of the Virgin Islands Code is amended as
- 3 follows:

- 4 (a) In subsection (b):
- 5 (1) Strike "June 1, 2013" and insert "June 1, 2020" in its place; and insert ", 6 inclusive of all government instrumentalities, the Legislature of the Virgin Islands, the 7 local Courts of the Virgin Islands and all semi-autonomous agencies." at the end of the
- 8 first sentence.
- 9 Strike the last sentence and insert the following sentence in its place:

1	"Information in the database must be presented in an intuitive manner for the
2	general public, including graphical representations."
3	(3) Add a new paragraph (1) which reads as follows: "The Office of
4	Management and Budget, the Department of Finance, and the Bureau of Information
5	Technology are responsible for dictating when and in what manner in which agencies will
6	provide financial information for publication on the official internet website."
7	(4) Add a new paragraph (3) which reads as follows: "Every agency required

9	of Finance, and the Bureau of Informational Technology according to this section must
10	also publish their financial information on their own respective websites for public access."
